#### I. Why should you read this Privacy Notice?

\t

myPOS is committed to the principles of personal data protection laid down in European and UK law and recognises the importance of safeguarding its customers' information. We are constantly improving our data processing activities and our privacy notices in order to provide you with as much transparency over the way we handle your data as we can. This Privacy Notice for myPOS Campaigns and Promotional Events describes how we collect, use, process, and disclose your information, including personal information, in relation to your participation in any myPOS Campaigns and Promotional Events.

If you see an undefined term in this Privacy Notice, it has the same definition as in our Legal Agreement for myPOS Account, Legal Agreement for myPOS Card, Merchant Agreement, Privacy Policy or other legal documents regulating myPOS Service to all of which this Privacy Notice is inseparable part.

### 1.1. About us.

\t

When this Notice mentions "we," "us," or "our," it refers to myPOS or an affiliate/partner of myPOS, which is responsible for your information under this Privacy Notice for myPOS Campaigns and Promotional Events. The specific responsible entity for your personal data may vary depending on the Campaign or Promotional Event and the country in which it takes places. The responsible entity in each case is referred to as the "**Data Controller**".

The responsible Data Controller is the organiser (or similar) of the Campaign or Promotional Event and may differ based on the country where the latter is carried out. Please refer to the terms and conditions for the particular Campaign or promotional event or the hyperlink above.

#### 1.2. myPOS Campaigns and Promotional Events.

For the purposes of this Privacy Notice, myPOS Campaigns and Promotional Events means any activity, undertaken by myPOS, in order to popularise or otherwise promote our services, by organising and processing personal data of participants and/or visitors of any public event, campaign, competition, promotional event, seminar, webinar, show, expo, open day(s), referral program, survey, quiz, game, sweepstake, contest or similar activity hosted in offline or online.



myPOS Campaigns and Promotional Events are carried out for the purposes of promoting our business and services to other businesses, individuals and entities. In case you are participating for or on behalf of an entity we will treat you as an authorised person and you may be obliged to disclose to us personal data of the legal representatives, employees, agents, beneficial owners or any other third party related to the entity pursuant to the rules described below. You certify that where you have provided information regarding any third person beside yourself you have received prior consent from that other person to provide their personal information to us.

This Privacy Notice grants rights only to natural persons participating in a Campaign or Promotional Event. Whenever we use "you", "your", or similar terms, we are referring to the natural person participating in any capacity in the myPOS Campaign or Promotional Event. Those persons may be a representative, beneficial owner, authorised person or similar, or if the person is a sole trader.

#### II. How do we process your personal information?

\t

We process your information in a secure, transparent, and lawful manner. Our processing activities are designed to protect your privacy while enabling us to provide and market services, enhance and improve customer experience, and fulfil our legal and regulatory obligations. The processing of your data includes:

\t

Collection: We collect only the data necessary to market and deliver services, analyse and improve user experience, and ensure compliance with legal obligations and regulatory requirements.

\t

Storage: Your information is stored securely, with measures in place to prevent unauthorised access, alteration, or disclosure.

\t

Usage: We use your data for the purposes specified in Sections II and III of our Privacy Notice.

\t

Sharing: Where necessary, we may share your information with trusted third-party processors, under strict data processing agreements. You can find more information about this in Sections II and III of this Privacy Notice.

\t

Retention: We retain your data only as long as necessary to fulfil its purposes and as required by law. Please see Section VI for more details.

\t

Deletion or Anonymisation: When your information is no longer needed, we securely delete or anonymise it to ensure your privacy. Please see Section VI for more details.

Where we are processing your data on the grounds of a statutory or contractual requirement (defined below as "our contract with you", "compliance with legal obligations" and other similar), this means that you are obliged to provide the personal data (or allow us to collect it from third-parties) in order for us to be able to provide access/participation to any of our Campaigns and Promotional Events.

# IV. Specific data processing cases.



In any case, we may share any of your information for specific reasons, outlined below:

**4.1. With other members of myPOS or iCard AD's corporate family:** We may share your Personal Data with members of the myPOS or iCard Group of companies or within our extended family of companies that are related by common ownership or control, so that we may organise, manage and facilitate the Campaigns or Promotional Events for which you applied or in which you participated, or to manage the risk, or to help detect and prevent potentially illegal and fraudulent acts and other violations of our policies and agreements.

**4.2. With our partners and distributors:** We may share information related to you or your company with our partners and distributors, if we are carrying out a joint Campaign or Promotional Event or if they are helping us organise, manage and facilitate a Campaigns or Promotional Events. In such cases, our partners and distributors may process some of your personal information.

**4.3. Aggregated data:** We may also share aggregated information (information about our users and participants in Campaigns and Promotional Events that we combine together so that it no longer identifies or references an individual user) and other anonymised information for regulatory compliance, industry and market analysis, demographic profiling, marketing and advertising, and other business purposes.

**4.4. With our legal counsels for the purposes of exercising and protecting our legal rights:** We may share any information which is necessary to allow us to exercise and protect our legal rights with our legal counsels or other relevant parties.

**4.5. Business transfers:** If any of the companies that organise, manage or facilitate Campaigns and Promotional Events, is involved in any merger, acquisition, reorganisation, sale of assets, transfer of portfolio, bankruptcy, or insolvency event, then we may sell, transfer or share some or all our assets, including your information in connection with such transaction or in contemplation of such transaction (e.g., due diligence). In this event, we will notify you before your personal information is transferred to a different legal person and/or becomes subject to a different privacy notice.

V. Decisions based solely on automated processing.

Sometimes, our systems may take decisions based solely on automated processing. This does not mean that we will always use automated decision making for these processing activities. In case you believe that you have been unfairly treated by our automated decision-making systems you may, at any time, ask that a person reviews the decision by contacting us as described in the "How do I complain?" section. Such decisions may be done for processing activities that include:

#### VI. Information collected about you from third parties.

### 6.1. Third parties with whom we organise, manage or facilitate any Campaign or Promotional Event.

We may receive information from our partners, distributors and third-party service providers who are helping us in organising, managing or carrying out one or our or a joint Campaign or Promotional Event. In such cases, our partners and distributors may process some of your personal information.

#### VII. Data retention and erasure.

We generally retain your personal information for as long as is necessary for the performance of the Campaign or Promotional Event and to comply with our regulatory obligations. If you no longer want us to use your information for the purpose of facilitating your participation in any Campaign or Promotional Event, you can request that we erase your personal information. In such event, we shall dispose of the data, provided that it does not contain information which is significant due to compliance, risk or regulatory reasons, that we are not obligated to keep the information by law. As a general rule, we usually keep information about your participation in Campaigns or Promotional Events for a period of 5 years.

Please note that if you request the erasure of your personal information:

We may retain some of your personal information as necessary for our legitimate business interests, such as fraud detection and prevention, enhancing security and other similar purposes.

We may also be obligated to retain personal data which we have collected for the purposes of complying with the relevant antimoney laundering and anti-terrorism financing for a certain period as defined under the applicable law;

We may retain and use your personal information to the extent necessary to comply with our legal obligations;

Because we maintain our records in a manner protecting from accidental or malicious loss and destruction, residual copies of your personal information may not be removed from our backup systems for a limited period of time;

We reserve the right to retain your identification data for an indefinite duration if you have been placed on our company's internal blacklist due to suspected malicious, fraudulent, or analogous behaviour. This retention is predicated on our legitimate interest in preventing such individuals from accessing our services in the future.

#### VIII. Your rights.

You may exercise any of the rights described in this section by contacting the respective Data Controller via email. Please note that we may ask you to verify your identity before taking further action on your request. Please note that upon receipt of your email we shall try our best to provide you with the requested information and resolve your request in reasonable time, subject to all obligations which we or the related companies have under the applicable laws.

### 8.1. Managing your information.

You have the right to obtain the following:

#### 8.2. Rectification of inaccurate or incomplete information.

You have the right to ask us to correct inaccurate or incomplete personal information concerning you (and which you cannot update yourself via access to your profile(s)).

# 8.3. Data access and portability.

### 8.4. Withdrawing consent and restriction of processing.

Where you have provided your consent to the processing of your personal information by us you may withdraw your consent at any time by contacting the relevant Data Controller via email and specifying which consent you are withdrawing. In case the Campaign or Promotional Event is carried our online and you have an Account you may withdraw your consent by updating the settings in your Account. Please note that the withdrawal of your consent does not affect the lawfulness of any processing activities based on such consent before its withdrawal. Additionally, in some jurisdictions, applicable law may give you the right to limit the ways in which we use your personal information, in particular if: (i) you contest the accuracy of your personal information; (ii) the processing is unlawful and you oppose the erasure of your personal information; (iii) we no longer need your personal information for the purposes of the processing, but you require the information for the establishment, exercise or defence of legal claims; or (iv) you have objected to the processing and pending the verification whether our legitimate grounds override your own.

### 8.5. Objection to processing.

In some jurisdictions, applicable law may entitle you to require us not to process your personal information for certain specific purposes (including profiling for marketing purposes) where such processing is based on legitimate interest. If you object to such processing we will no longer process your personal information for these purposes unless we can demonstrate compelling legitimate grounds for such processing, or such processing is required for the establishment, exercise or defence of legal claims.

Where your personal information is processed for direct marketing purposes, you may, at any time ask us to cease processing your data for these direct marketing purposes by sending an email to the contact emails below.

# 8.6. Opting out.

# 8.7. How do I complain?

To facilitate our global operations, we may be required to transfer, store, and process your information within our family of companies or with service providers based in Europe, India, Asia Pacific and North and South America. For example, information collected within the EEA may be transferred, stored, and processed outside of the EEA for the purposes described in this Privacy Notice. Where we transfer store and process your personal information outside of the EEA we have ensured that appropriate safeguards are in place to ensure an adequate level of data protection.

### XII. Can children participate in our Campaigns and Promotional Events?

Our Campaigns and Promotional Events, unless explicitly stated in the Terms and Conditions, are not designed to individuals under the age of 18. We do not knowingly collect information, including personal data, from children or other individuals who are not legally able to participate in our Campaigns and Promotional Events. If we obtain actual knowledge that we have collected personal data from an individual under the age of 18, we will promptly delete it, unless we are legally obligated to retain such data.
